2024 Fees and Levies Schedule



As a Catholic school, St Matthew's Primary School is not fully funded by government grants. To ensure the school can provide quality education and resources to all students, fees and levies are collected from families.

School fees and levies are generated on a **term-by-term basis**. Statements are emailed within the first two weeks of each term from pcoufinance@bne.catholic.edu.au to each account holder. The due date for payment is within fourteen (14) days of the issue of the statement. The due date will be noted on the statement.

The school finance office encourages full settlement of fees and levies each year to ensure school accounts remain manageable. Payment options include: BPay (details on statement), Credit Card (BPoint link in Parent Portal and newsletter) and EFTPOS (school office). School fees and levies paid on time supports the school with meeting its ongoing financial obligations. **BPay is the school's preferred payment method.**

Families wishing to make regular weekly or fortnightly payments are permitted to submit a [direct debit](#) or [credit schedule](#) to the [school finance office](#). To support calculating your direct debit/credit payment amount please use the [Ready Reckoner - Archdiocesan Development Fund \(brisbanecatholic.org.au\)](#) and ensure your final payment date is no later than Friday 6 December 2024. A direct debit or credit schedule must be reviewed and renewed each year.

At St Matthew's our aim is that no Catholic student will be denied a place at our school due to parents' genuine inability to pay fees and levies. Families who believe they may not have capacity to pay school fees and levies are encouraged to contact the [school finance office](#) to discuss concession eligibility.
