St Matthew's Primary School is not fully funded by government grants and therefore relies on the prompt payment of school accounts to maintain high-quality educational programs and resources.

School fees and levies are generated on a <u>term-by-term basis</u>. Statements are emailed within the first two weeks of each term from <u>pcoufinance@bne.catholic.edu.au</u> to each account holder. The due date for payment is within fourteen (14) days from the issue of the statement. The due date will be noted on the statement.

School fees and levies paid on time supports the school with meeting its ongoing financial obligations, including staffing and resource allocation. Full settlement of fees and levies each year is required to ensure school accounts remain manageable.

Payment options include: BPay (on statement), Credit Card (BPoint link in Parent Portal) and EFTPOS (school office).

BPay is the school's preferred payment method.

St Matthew's has partnered with FACTS Management Australia to offer you a flexible plan to manage your school fees and levies by way of regular instalments. All plans must clear the school account by the **last day of school.** Detailed information regarding how to sign up to FACTS will be shared with families, early in Term One 2026.
